INCI NAME: WATER / PORTULACA OLERACEA EXTRACT / GLYCERIN




Portulaca is to be derived from the Latin 'porto' to carry and 'lac' meaning milk, since the plant contains a milky juice [1]. An extract of the whole plant of Purslane (Portulaca Oleracea L.), a Traditional Chinese Medicine, is well known for its traditional usage to treat burns, earache, insect stings, inflammations, skin sores, ulcers, itching skin, eczema and abscesses. It is also eaten as a salad and vegetable all around the world and used medicinally for a variety of conditions such as headache, painful urination and in postpartum bleeding [2].



# Processing & Dosage

The recommended dosage of PORTULACA EXTRACT GN is 0.5-5% to obtain a significant anti-inflammatory, antiirritation and anti-allergy effect. PORTULACA EXTRACT GN is a water soluble active ingredient. In order not to disturb the structure and conformation of the actives it is recommended to incorporate it into formula at the last phase of the formulation at about 40°C.

# Storage & Shelf life

PORTULACA EXTRACT GN should be stored at room temperature in a tightly closed and lightproof package. If stored in these appropriate conditions the shelf life is at least 24 months. Once the original packing is opened, it is highly recommended to use at once.

The toxicological profile of PORTULACA EXTRACT GN was fully assessed in order for the registration as an inactive


