
#### SHELF LIFE:

18 Months away from light and heat source, closed containers.

# **CLAIM SUBSTANTIATION:**

IN VIVO: Cultured NIH 3T3 cells pretreated with different % of PHYTO-COMPLEX DET (0,5-6,0%) overnight followed by 2h of  $50\mu$ M of H2O2 stimulation. After-

wards, the cell were washed to remove H2O2 and incubate with fresh medium for 48 hours. At the end of this period cell viability was assessed using MTT assay.



In an In vitro test, carried out on monolayer cell culture of NIH 3T3, PHYTO-COMPLEX DET has showed to be effective in the reduction of toxic effects produced by treatment with hydrogen peroxide, increasing the cell viability of more than 40%
